INSTRUCTIONS FOR COMPLETING THE APPLICATION FOR ADMISSION  
TO THE MASTER OF LAWS (LL.M.) FOR FOREIGN LAW GRADUATES

It is recommended (but not required) that international applicants register with the Credential Assembly Service provided by the Law School Admission Council (LSAC). This service collects and authenticates the academic records and TOEFL scores of applicants and directs the reports to requested schools. Please see [www.llm.lsac.org](http://www.llm.lsac.org) for more information and to register for the service.

**Checklist of Required Application Materials:**

- Completed and signed LLM Application for Admission
- Copies of all academic records, mark sheets, and/or transcripts from all post-secondary institutions attended. **Scanned copies are acceptable for the admissions decision**, but certified/official copies must be received before the start of classes. Where the official original documents are issued in a language other than English, certified English translations must also be submitted. Certified copies of the original certificates or diplomas awarded at the completion of studies must also be submitted.
- Evidence of English Proficiency in both spoken and written English. Applicants to the twelve month program must show a high level of English proficiency either through a standardized test, English education transcripts, and/or letters of recommendation that comment on English language skills. Applicants to the 18 and 24 months program must show evidence of good or solid English skills, respectively. Applicants may be required to participate in an interview to verify English skills.
- Resume or curriculum vitae
- Photocopy of official law license document (if applicable)
- Personal Statement
- Completed and signed Certification of Financial Responsibility
- Up to three letters of reference written on official letterhead.
